Management has additional responsibilities to demonstrate leadership and high standards in health and safety, and is ultimately accountable.

Employees must know how to keep themselves and those around them safe. They should receive suitable training on the hazards they face and the control measures to be applied.
- Working safely is a condition of employment for all employees and contractors. A commitment to work safely can only be demonstrated by our actions ... or inactions.
- Excellence in health and safety drives excellent business results. Without a healthy and safe operation there can be no business
- Safety and health is integrated into all our business management systems and processes. Sound business decisions cannot be made without genuine consideration

The Management

- Providing a safe working environment for all employees, subcontractors and other affected parties

- Educate employees of the hazards associated with the work process and/or Ensure that the employees follow Client's and Company's safety policies, instructions, safety procedures etc. environment and update them regularly
- Ensure that all accidents are reported, reasons identified and corrective action is taken to eliminate the cause.

The Employee

- Comply with company policies, procedures and instructions during and after work.
- Use the correct PPE, tools, tackles and equipment for the job in the right way
- Attend all training, understand and follow safety instructions given by client, e safety engineer, supervisors, foremen, engineers, etc.
- Report all accidents, near misses or hazardous conditions to their immediate supervisor or to management
- Take all protective measures and precautions to protect themselves and their fellow employees
